Please limit each query to 10 typed lines, including your


Please limit each query to 10 typed lines, including your name and address. A query should provide at least 3 items: name(s), date(s) and location(s).

Gleanings from local newspapers

Paris Daily Beacon (Monday, April 29,1912)

Mrs. Sarah McClain passed peacefully away, Sunday afternoon April 28th, 1912 at the home of her daughter, Mrs. Emmet Vance of N. Main street. For nearly three years, the health of the deceased has been failing. Her death is the termination of several months' illness. Sarah Ann French was born near Lexington, Ky., Aug. 27, 1829 and came with her parents, when a small child to Illinois, settling near Old Bloomfield, she being the last of a family of eight children. She was married to Lewis M. McClain, May 28, 1851, who preceded her to the better world Dec.31, 1871, to this union five children were born, only one, Mrs. Emmet Vance surviving. She united with the Baptist church when very young at Bloomfield, then moved her membership to Paris, being one of the charter members of this congregation and living a consistent Christian life until the end. She was a woman of great energy and force of character constantly serving other. In her Master's service, no task was too humble, no service too great for her to undertake.

She lived a noble devoted life, combining high mindedness, refinement, confidence in her power, with rare humility and considerateness. One quickly came to reply [sic] upon her good judgment and her absolute faithfulness. Her life was one of patience never murmuring or complaining and was beloved by all who knew her. Many neighbors and friends will miss the gentle words and kindly acts, to give and to do, that others might be blessed. God's finger touched her and she sleeps, and is at last at perfect rest, forever free from pain. The funeral will be Tuesday at 1:30 p.m. at the home of Emmett **Vance** on N. Main street, conducted by Rev. L. S. **Shumaker** of the First Baptist church.

Paris Daily Beacon (Monday, April 16,1928)

The funeral of Mrs. H. Emmet **Vance**, who passed away at 5:36 o'clock Saturday afternoon, will be held from the residence, 609 North Main Street at 2:30 o'clock Tuesday afternoon, the Rev. F. C. **Weber** officiating. Burial will be at Edgar cemetery.

Mrs. **Vance** had been in ill health for more than a year and was confined to her bed for two weeks. She was formerly Emma **McClain**, daughter of Lewis and Sarah **French McClain**, who was born 62 years ago near Bloomfield, south of Chrisman. She had resided in Paris and vicinity all of her life. On August 27, 1887, she was united in marriage to Mr. **Vance**, who survives with a daughter, Ethel, at home. A daughter, Helen, is deceased.

Mrs. **Vance** was a member of the First Baptist church for many years, being active in every department.

Paris Daily Beacon (Saturday, November 13,1943)

Death came to Henry Emmet **Vance**, 81, at 7:50 o'clock Friday night at Paris Hospital, where he was taken Friday morning from his home, 609 North Main Street. His death was attributed to intestinal influenza and a hear complication.

He was born in Paris on October 22, 1862, a son of James L. and Sarah **Brown Vance**. His entire life had been spent here, where for many years he had a prominent stock dealership.

On October 2, 1881 he was married to Emma McClain, who died in 1[9]28. To this union were born two children, Helen Estella, who died in infancy, and Ethel B. **Vance**, at home, who is a teacher at the Redmon school.

Also surviving are three brothers, J. Edward **Vance** and Robert Burns **Vance** of Paris, and J. Warren **Vance** of Akron, O., three nephews, Archie N. and George B. **Vance** of Los Angeles, Calif., and John **Vance** of Chicago, and two nieces, Mrs. Janet **Alms** of San Rafel, Calif., and Mrs. Edythe **Vance Akers** of Akron, O.

Mr. **Vance** had been a member of First Baptist Church since 1897. Funeral services will be conducted at Morrison's Chapel at two o'clock Monday afternoon with Rev. D. T. **Wickstrom** officiating. Burial will be at Edgar cemetery. The body will remain at the funeral home.

Paris Daily Beacon (Tuesday, April 30,1912)

Mrs. Nancy **Newman**, one of the aged residents of Edgar County passed away at her home here (Brocton, Ill.) on Monday morning of general debility. She had been ill for a number of weeks and her condition has been extremely critical for several days.

Mrs. **Newman** came here when a young woman. She was first married to John **Malott**, of which union one daughter, Miss Lola **Malott**, survives. Mr. **Malott** died and she was married a second time to Porter **Newman**, who is also dead. of the second marriage, one son and two daughters survive, viz: Mrs. Rachel **Gobert**, of Brocton; Mrs. John **Liston** of Fairfield, Ill.; Ben **Newman** of Oakland, Ill.

The funeral will take place from the late residence at 10:30 o'clock Wednesday, Elder **Show** officiating. Burial will be in Payne cemetery.

The funeral of the late John **Jump** (Brocton, Ill.) will be conducted from the M. E. church at 9 o'clock Wednesday morning Rev. D. B. **Houck** officiating. Burial will be in the Rudy cemetery.

Able **Burris** aged 55 years, died at 10:30 o'clock Sunday night at the family residence, eight miles northeast of Chrisman, following a year's illness of stomach trouble. He had been seriously ill since Friday. The body will be taken to Paris Wednesday morning. The funeral will be conducted Wednesday at the Stephens church eight miles southwest of that city. Mr. **Burris** is survived by his wife and several children.

Paris Daily Beacon News, (Thursday, November 11, 1943)

The death of Mrs. Kittie **Lake Touhey**, 53, former resident of Hume, Ill. occurred at 2 o'clock Wednesday afternoon at St. Anthony's Hospital, Terre Haute.

Funeral services will be held at ten o'clock Friday morning at Callahan's funeral home, Terre Haute, with Rev. Samuel E. **Carruthers** officiating. Burial will be at Edgar cemetery, Paris.

Mrs. **Touhey** was born June 7, 1890 at Johnston, O. For six years after her marriage to Dan **Touhey** she resided in Hume. Surviving are the husband, one son, Phillip of Paris; the parents, Mr. and Mrs. Jake **Lake** of Johnston, O; a granddaughter, Patricia Ann **Touhey** of Paris; three brothers, Edward and Robert of Battle Creek, Mich., and Bernard of Indianapolis and one sister, Mrs. Lema **Martin** of Pasadena, Calif.

After a year's illness, Mrs. Clara **Schlatter**, 49, died at 4 o'clock this morning at her home in Chicago. The body will arrive in Paris early Friday morning and will be taken to the Cook & Wright Funeral home where the funeral will be held at two o'clock Saturday afternoon. Burial will be at Franklin cemetery.

Surviving are two children, Mrs. Mary Bells **Schoots** and John, both of Chicago; also three brother and five sisters, Floyd **Northup**, Toledo, O., Clifford **Northup** and Mrs. Ruth **Throneburg**, Terre Haute, Herbert **Northup** and Jessie **Northup** of Chicago, Mrs. Nora **Robertson**, Montezuma.

Paris Daily Beacon News, (Friday, November 12, 1943)

Mrs. Rachel Ann **Parrish**, 72, wife of Otis Clay **Parrish**, died at 12:30 o'clock Thursday morning at residence near Logan, the daughter of Vina and Sara Jane **Runyan Clark**. She was married on November 12, 1899 to Otis Clay **Parrish**, and their entire married lives have been spent in the Logan community.

Surviving besides the husband are a son, Stanley, of Logan, two daughters, Mrs. Ada **Hopper**, Terre Haute and Mrs. Nonia **Parker** of Scottland, Ill. and eight grandchildren. Lt. Nye **Jenkins**, who was reared in the Parris home, is stationed at Santa Cruz, Calif. A daughter, Hazel, is deceased. Also living is a brother, Howard **Clark**, of Scottland, and a sister Mrs. Mayme **Haws** of Chrisman.

Mrs. **Parrish** was a member of Scottland Eastern Star chapter and the Logan Methodist Church.

The body was taken to the residence last night from the Scott funeral home. Funeral rites will be held at two o'clock Sunday afternoon from the Logan Methodist church and burial will be at Mr. Carmel cemetery.

Funeral services will be held at two-thirty o'clock Saturday afternoon at Second Baptist church. The body which is at the Zieren funeral home will lie in state at the church for one hour prior to the funeral service. Burial will be at Edgar cemetery.

Hume, Ill.- Mrs. Lottie **Connelly** and Mrs. Lydia **Markle** of Hume attended the funeral of Mrs. Nannie **Clark** in Indianapolis Saturday. The deceased formerly resided in Hume. She is survived by three daughters, Mrs. Daisy **Applgate** and Mrs. Claudia **Horn** of Indianapolis and Ruby of California. A son, Ross, preceded her in death.
