WWI&WWIIMemorial

During the March 6, 2017 meeting of the Edgar County Genealogical Society, Verlin **Funkhouser** current caretaker, presented a program on the WWI & WWII memorial that is on the east side of the courthouse square in Paris.

This memorial was dedicated on October 7, 1945 to the veterans of these two wars. Over the years, it has been weathered and damaged by the elements and Verlin is painstakingly working to revive the memorial to its original glory. He is also working to get a grant, "100 Cities, 100 Memorials", to help further recondition the memorial and add more names. There will be a fundraising effort in the future to also help with this cause.

Veterans from Korea, Vietnam, the Gulf, and other conflicts are listed on the wings of the current memorial.

If you have a relative from Edgar County that served in any capacity and their name is not listed on the memorial, please contact Verlin and he will work to get the information so they can be added. Currently, a DD214 is needed to add a person to the memorial.

Verlin also thanked the volunteers at the Edgar County Genealogy Library for their help in getting information.

If you are not local and would like to contact Verlin, please contact the ECGS and they can put you in touch with him.

Thank you Verlin for your time and effort in honoring these local men and women that have faithfully served our county. May we never forget their service and sacrifices.

Paris Daily News Paris, Illinois Thursday, December 23, 1915 page 1

Judge Dismisses **Dinsmore** Suit – Sustains Motion Presented By Attorneys For Defendant.

Judge Walter **Brewer** of the circuit court Thursday afternoon set aside the verdict of the jury in the case of Enroy **Dinsmore** against Bert **Dinsmore** and the other children of George O. **Dinsmore** and sustained a motion on the part of attorneys for the defendant dismissing the suit for want of equity.

Recently a jury, the fourth to hear the case, decided in favor of the plaintiff, who alleged in his complaint that Bert **Dinsmore** had procured deeds to three tracts of land by undue influence over his father. The case has cost the county and parties to the suit hundreds of dollars and has occupied considerable time.

The court in making his ruling said that under ordinary circumstances he doubted if the jury would have agreed. He said he believed according to he had a perfect right to decide the case, as he did and that he believed other judges would have had the same right. The court said in justice to the county and the parties to the suit there should be some decision made and the case should not be passed over again.

Four charged With Gambling

Following an information filed in county court Tuesday by State's Attorney Hickman, John Ballard, G.W. Wasson, J. C. Kellar and Chester Johnson appeared in court Thursday morning and gave bond to answer to a charge of operating a pool room for gambling purposes in Chrisman. The bond was fixed by Judge **Dayton** at \$100 and the case will be heard at the April term of court. The men gave themselves up.

Administrator Appointed

Following a petition filed in county court Thursday morning C. A. Newkirk was appointed administrator of the estate of the late Elenora **Smick**. Personal bond in the sum of \$800 was given.

Miss **Brunsman** Critically Ill

Miss Teresa Brunsman of Vance avenue, who has been confined to her bed with diabetes for more than a week, suffered a severe attack at 8 o'clock Thursday morning and has since been in a critical condition. The attending physician gives no hope for her recovery. She is suffering with convulsions.

One daughter, Mrs. Forrest **Hanks** is deceased.
